Step 1: Allotment order has to be obtained from Management Office

- Report at Admission Section, RVITM, 8th Phase JP Nagar, Bengaluru then report at Computer Centre (Ground Floor) for completing official formalities.
- Verification of admission order issued by respective authorities and original documents

Step 2: Mention Student Name, Mobile No, Branch Name on the back side of DD/UPI receipt.

- DD to be handed over to the Cashier in person at Computer Centre (Ground Floor).
- Fees can also be paid using NEFT/UPI and transaction slip to the Cashier in person.

Step 3:

- After Submitting DD/NEFT/UPI details to the Cashier, the candidate will be allowed for the entry of the application form in the systems put-up in the computer center.
- After entry of application form, take a Printout of the application, then, the candidate & parent have to affix the signatures and submit all the necessary documents as given below to the admission authority in the computer center.
